VILLAGE MEMBERSHIP OPTIONS

PNA is a 501(c)(3) organization (Tax Id # 91-1112780). For full members, your PNA membership portion (\$50 for individuals, \$80 for households) is 100% tax deductible. All but \$50 of the Builder membership is tax deductible. All donations are tax deductible.

PNA Village Membership Agreement

This Agreement of Membership is entered into by and between the undersigned "Member" and PNA Village, a program operated by the Phinney Neighborhood Association (PNA).

Membership & Fees: In addition to PNA Village services and activities, your membership also includes membership in the Phinney Neighborhood Association. Membership runs for twelve months beginning from the date of payment. The annual fee may be increased from time to time, and annual membership may be renewed subject to agreement between the PNA Village and Member upon receipt of the fees listed at the time of renewal.

Member Expectations: To be a PNA Village member, you must be capable and self-sufficient in these areas:

- Making key decisions about your own life and coordinating your own support needs (exceptions can be made if there is an active care manager);
- Meeting your own personal care needs and activities of daily living, either by self-care or with caregiver support;
- Reliably communicating with Village Staff and Volunteers, either by phone or email;
- Providing PNA Village with permission and information for whom to contact in an emergency;
- If requesting services in your residence, your residence must present no known threats to health or safety;
- If requesting transportation services, you must be able to get in and out of the car on your own.

PNA Village reserves the right to deny or discontinue membership in the event that an individual does not meet the member expectations listed above, or determines that their needs are otherwise incompatible with PNA Village capacities. PNA Village may also discontinue membership if an individual is not complying with PNA Village's Community Values. If membership is discontinued, a pro-rated portion of the membership fee will be returned.

PNA Village Community Values: We - the members, staff and volunteers of the PNA Village - aspire to create a community built on respect, equity, collaboration, and belonging. We recognize that diversity is essential to the health and vitality of every community. In our shared space, we do not tolerate discrimination, alienation or preferential treatment on the basis of race, gender, sexual orientation, education, economic status, social beliefs, religion, political beliefs or any other marker of cultural or personal identity.

Privacy Policy: Confidentiality is very important to the PNA Village. The PNA Village will take all reasonable steps to protect the personal information of its members. However, where concerns regarding a Member's health or safety arise, the PNA Village reserves the right to contact the individual(s) listed as non-member contacts or other appropriate people, as determined by the PNA Village.

Release and Waiver of Liability: To the extent permitted by law, I agree to indemnify and hold the PNA Village program, together with the agents, owners, employees, volunteers, and all other persons or entities acting in any capacity on its behalf, and the PNA (hereinafter the "PNA Village Released Parties") harmless for any loss, expense, or liability arising in any way out of their activities, including but not limited to any action I, my heirs and assigns, or my insurance company might bring for negligence, personal injury, or invasion of privacy.

I understand that neither the PNA nor the PNA Village is affiliated with the third party vendors it identifies as Vetted or Recommended Vendors, and I release the PNA Village Released Parties from all responsibility or liability stemming from the conduct, service or product of such third party vendors.

I understand that the PNA Village is not a provider of emergency services or health-care and does not employ licensed health professionals or social workers. This agreement is not meant to create any special relationship which would give rise to a duty to aid or protect between myself and PNA Village Released Parties.
