Additional Fees

All Day Care Days – School Year: 8:30 – 4:30 \$65.

Separate fees and registration apply for All Day Care days such as Winter Break and SPS Staff Development days. All Day Care sign-up information is sent out to families three weeks in advance. Whittier Kids is not open on holidays.

Annual non-refundable Registration Fee: \$75 and \$100 deposit which will be applied to your first month's tuition. Families will also be billed for an annual Phinney Neighborhood Association membership in the fall.

Monthly tuition: Rates above are based on the school year divided equally into 10 monthly payments, regardless of the number of days of care per month. This provides families with a consistent monthly payment. Full payment is charged each month regardless of absences, holidays and school breaks.

- After School Rates include all activities, an afternoon snack and care from the release bell -6:00pm (school is released early on Wednesdays).
- Every Wednesday is a 75min early release day. If your child normally attends on Wednesdays, extra care is provided starting at the release bell and is included in your monthly tuition.
- Late Pickups: If a child is picked up after WK's scheduled end time, the late pick-up fee is \$5 for the first 1-5 minutes and \$2.00 per minute for every minute thereafter (see handbook for more details).

Payments – Invoices are emailed out to families monthly on the 28th of each month and tuition is due by the 10th (or next business day). Payments received after the 15th of the month will incur a \$35 late payment fee which will be included on the next month's statement. Whittier Kids accepts checks, ACH drafts, and all major credit cards. Whittier Kids also accepts DSHS (State of Washington) or CCAP (City of Seattle) subsidy payments. <u>City & State resources</u> to help pay for child care are available. As of September, 2024, Whittier Kids will charge an additional 3% convenience fee for credit card payments.

Schedule Changes– As long as there is space available, schedule changes can be made on a monthly basis. Schedule changes must be received by the fifteenth of the month in order to change the billing amount for the next month. There will be a \$25 schedule change fee assessed for all approved changes.

Withdrawal/Refund Policy – Whittier Kids requires 30 days' notice to withdraw from our program. Whittier Kids does not offer credits for absences, vacations or unexpected weather or health and safety related closures.

Receipts –The PNA tax identification number is 91-111-2780 and is listed on all invoices. Receipts are provided by request. In January 2025, you will receive a year end statement detailing all payments made to Whittier Kids in 2024.
